- CFR, tasked by the COVID Deputy Minister Committee, co-chaired an interdepartmental working group to develop occupational health safety guidance for federal employees working in the field. This working group also conducted a scan of lessons learned from COVID response
- CFR created a Network of compliance and enforcement executives in the early days of COVID response to enable information sharing across departments on issues related to personal protective equipment, occupational health and safety and virtual inspection

Pivot CFR's suite of learning events to online delivery (including REGTalks, Let's Talk, Regulatory Speaker Series and other specialty events)

CFR 2020 Conference cancelled due to COVID-19; select elements of the conference programme were scheduled for staggered virtual delivery over 2020-2021 as 'REGTalks' (see initial virtual events below)

Support implementation of an Online Regulatory Consultation System – 'ORCS' by participating in interdepartmental governance and supporting community outreach

 CFR sits on both the Working Group and Steering Committee of ORCS, representing the line departments. CFR to continue supporting TBS and PSPC in their work on developing ORCS and consulting with departments in advance of its launch

Support the Centre for Regulatory Innovation's rollout by participating in multi-level governance (e.g. assessments) and supporting specific projects, as requested

 CFR sits on both the Working Group and Steering Committee of the CRI and supported the launch of intake and screening for Phase 1 of funding allocation.

Support community-led pilots (e.g. Rules as Code II, Regulatory Metadata Project) which align with Canada's Regulatory Modernization Agenda

 CFR developed an Memorandum of Understanding with CSPS to provide funding and participate on the next phase of the Rules as Code Pilot with the Labor Program (Trucking Overtime Regulations); as well as support ECCC efforts in developing a Regulatory MetaData project
