



- GIT is a start-up (est. 2017) marine vessel coating technology company committed to advancing the shipping industry toward a more environmentally friendly future. They achieve this by offering sustainable and effective graphene-based coatings used on the hulls of vessels.
- Their coating technology offers:
 - Low friction decreasing drag and subsequently reducing fuel consumption
 - Self cleaning of biofoul
 - Stronger & less layers of coating required
 - Minimal leaching of product into oceans
- How GIT aligns with ACOA's priorities:

 - Knowledge-based company

\$125,000 - \$10 million per project Up to 50% of eligible project costs


