Terms

• co-development (noun)

Definition

A joint process or partnership in which people with different world views work together on a jointly defined matter to meet common objectives.

Notes

Co-development is based on mutual respect and recognition of the rights and cultural differences of the parties involved, allowing them to be on an equal footing. It also requires trust, understanding and transparency between the parties and an open and ongoing dialogue.
