### **The amended Directive on the Implementation of the Official Languages (Communications with and Services to the Public) Regulations**

The amended Directive on the Implementation of the Official Languages (Communications with and Services to the Public) Regulations will take effect at the end of this summer. Last fall, formal consultation on the proposed amendments took place and institutions were invited to provide feedback. These formal consultations were completed in February, and the amendments were well received for the most part by all stakeholders.

The Directive outlines the terms and timeframes for implementing the *Official Languages (Communications with and Services to the Public) Regulations*. The Regulations specify the circumstances under which federal institutions are required to provide their services in one or both official languages. They were amended in 2019. The Directive was modified to reflect these amendments and provide further support to institutions.

The amended Directive will be used to help institutions implement the modified Regulations during the Official Languages Regulations Re-Application Exercise (OLRRE). This exercise will be coordinated by TBS and conducted in a phased approach, starting in fall 2022 until 2025.

As part of this exercise, federal institutions will be required to review the linguistic designation of their offices. This will involve nearly 10,000 federal offices and nearly 700 additional offices could become bilingual across Canada. Some institutions may have to take a few steps to determine the language designation of their offices. For example:

- identify the geographic area served by their offices,

- measure the demand for services in the official language of the minority population, and/or
- consult the official language minority population they serve to determine the location of their bilingual offices.

Persons responsible for official languages (PROL), HR Council and OL Champions have been informed of the upcoming exercise. Institutions must plan for the human and financial resources required during the upcoming fiscal year.

## TOOLBOX

### Reminder: signature block requirements

The TBS Standard on Email Management (SEM) that included detailed guidance on the use of email signature blocks and official languages requirements was recently rescinded. It was replaced by the [Email Management Services Configuration Requirements](#) under the new Appendix G: Standard on Enterprise IT Service Common Configurations on May 04, 2022 (see section 5.5.3).

We would like to remind you that official language requirements for signature blocks found in the Directive on Official Languages for Communications and Services still apply when signature blocks are used:

**6.3.5 (E-mails and voicemails)** Ensuring that employees who occupy bilingual positions have e-mail signature blocks, voicemail messages and automated messages that are complete in each of the two official languages.
