

Description

- Justified by the success achieved with the first edition and to continue the
 efforts and work accomplished on the importance of official languages at
 Employment and Social Development Canada (ESDC), the Bilingo challenge
 was held for the second consecutive year.
- The Bilingo challenge is a departmental initiative led by the National Official Languages Co-champions that takes place over a period of six (6) weeks in the form of friendly competition between branches and regions across the department.
- The purpose of the Bilingo challenge is to inform, raise awareness and/or promote employees' rights as well as the department's official languages obligations for Parts IV, V, VI and VII of the Official Languages Act (OLA).
- Design and implementation are done in a technological environment so that interactivity, accessibility and access to data is possible.
- Hosted on the intranet, all ESDC staff are invited to complete various activities of the Bilingo card.
- A participation voucher must be submitted to confirm participation.
 Satisfaction questions are included in the participation voucher, allowing data (participation rates, participant feedback, etc.) to be used for evaluation and reporting purposes.



Communication, engagement, and sustainability

- Assistant Deputy Ministers and their executive teams are called upon to act as ambassadors to:
 - Promote the Bilingo challenge and encourage people to participate
 - Taking concrete action to lead by example
 - Contribute to the success of the initiative
- A dynamic and diversified communication approach and products broadcasted throughout the initiative.
- ESDC's Official Languages Program slogan, "Official languages are everyone's business!" is used as a reminder of the importance of collective commitment to official languages.
- The three branches/regions with the highest participation rates receive a signature block as a "medal" of the winners. In addition, signature blocks are part of a communication and engagement strategy.
- The data collected will make it possible to take concrete actions such as:
 - Develop more targeted departmental communications products based on quizz results
 - Make a post-mortem assessment
 - Plan future initiatives based on lessons learned
 - o Etc.
- Bilingo card activities will remain available through the *Toolkit* available on ESDC's Official Languages Program intranet page.


