

# OFFICIAL LANGUAGES (OL) IMPACT ANALYSIS TOOL (ANNEX E OF MC)

#### Overview

**Objective:** The *Official Languages Act* establishes French and English as the two official languages in Canada and establishes requirements for all federal institutions. As both an important employer and service provider, IRCC must consider its legal obligations under specific sections of the Act for an efficient impact analysis:

- Part IV: Communications With and Service to the Public
- Part V: Language of Work
- Part VI: Participation of English-speaking and French-speaking Canadians
- Part VII: Supporting the vitality and development of Official Language Minority Communities and promoting the advancement of both English and French in Canadian society
- Article 91 (from Part XI: General): Staffing generally

### **Key Definitions:**

Official Languages: English and French

<u>Official Language Minority Communities:</u> Generally speaking, official language minority communities include Anglophones in Quebec and Francophones in the rest of Canada.

<u>Staffing Action</u>: assignments, secondments, deployments, acting appointments (less and over 4 months), term and indeterminate appointments.

<u>Designated Bilingual IRCC Office for Communication and Service to the Public purposes:</u> All IRCC offices with the exception of Scarborough.

Designated Bilingual IRCC Offices for Language of Work purposes: Offices located in the following regions:

- The National Capital Region
- The Province of New Brunswick
- The bilingual region of Montreal
- The bilingual region of Eastern Ontario:
  - The county of Glengarry including Alexandria
  - o The county of Prescott including Hawkesbury and Vankleek Hill
  - The county of Russell including Rockland
  - The county of Stormont including Cornwall
- The bilingual region of Northern Ontario:
  - The county of Algoma including Sault Ste Marie, Blind River, Bruce Mines and Thessalon
  - The county of Cochrane including Cochrane, Hearst, Iroquois Falls, Kapuskasing, Smooth Rock Falls and Timmins
