Prototypes Identify new projects to prototype the use of new approaches in future regulatory work (ie. artificial intelligence, behavioural economics, Internet of Things, Blockchain)	Q1-Q4
eRegs Support the newly established Government of Canada eRegs Committee [Budget 2018 tasked Treasury Board of Canada Secretariat to develop an e-regulation system to engage Canadians on regulation in order to improve the transparency and efficiency of the overall rule-making process.]	Q1-Q4
