#### Amendments to the Directive on the Implementation of the Official Languages Regulations - Communications with and Services to the Public

The amended <u>Directive on the Implementation of the Official Languages</u> (Communications with and Services to the Public) Regulations was approved by the President of the Treasury Board on August 23. The Directive was sent to Persons responsible for official languages (PROL) by email on September 7, 2022, to inform them of its coming into force and the actions that they will have to undertake. The Directive is also now published on the Treasury Board Secretariat's website.

The amended Directive will allow institutions to implement the <u>Official Languages</u> (<u>Communications with and Services to the Public</u>) <u>Regulations</u> that were modified in 2019. The modifications to the Regulations will be implemented during the Official Languages Regulations Reapplication Exercise (OLRRE) that will be launched at the end of 2022. As part of the OLRRE, institutions will have to review the language designation of their offices. This will require some institutions to take specific steps, including:

- defining the service area, in other words the geographical zone served by their offices
- measuring client demand for services in one or both official languages

 consulting with the official language minority community served to determine the location of bilingual offices based on the proportionality rule.

#### Tools, resources, and training



The <u>Best Practices Guide for Measurement of Demand</u> and the <u>Guide for Federal Institutions regarding the Obligation to Consult or</u> <u>Inform the English or French Linguistic Minority Population</u> help institutions on the most appropriate way to undertake some of these steps. The <u>Q&A on the Amendments to the Directive on the</u> <u>Implementation of the Official Languages Regulations</u> provide details on the amended Directive.

In the coming months, the Official Languages Centre of Excellence will be offering training to PROL on the OLRRE, as well as targeted presentations for each of the steps to help guide them through the required actions and tools to carry out this exercise.

### Connections

#### 2022-2023 Management Accountability Framework

The launch of the 2022-23 Management Accountability Framework (MAF) exercise is scheduled for the end of September for some 50 large departments and agencies. One of the People Management Area of Management (AoM) questions will focus on official languages. We encourage you to contact your institutions MAF co-ordinator to offer your support in the development of the response, and to give evidence in support of the answer provided.

The MAF is used to set management expectations for sound public sector management based on the Treasury Board's policy suite, including the *Policy on Official Languages*, assess organizational practices and performance across key areas of management, hold deputy heads accountable for organizational management, and support the continuous improvement of management practices. The results of the MAF People Management AoM will generate insights into planning and management practices that contribute to a diverse, inclusive, healthy, and agile public service.

# Community



The President of the Treasury Board of Canada, the Honourable Mona Fortier, was one amongst some 330 participants at the Official Languages Summit held on Thursday, August 25, 2022, at the National Arts Centre in Ottawa. That day marked the closing of public consultations across the country to lay the groundwork for the next Action Plan on Official Languages expected in spring 2023. Most of the participants were representatives from official languages minority community organizations.

The President emphasized that amendments made in 2019 to the *Official Languages (Communications with and Services to the Public) Regulations* are such that, for the first time, bilingual families and immigrants speaking a minority language at home will be part of the calculations when assessing the demand for bilingual federal services. Furthermore, the presence of a minority school in the service area of a federal office

is now a criterion for bilingual designation. The Secretariat will carefully analyze the linguistic data from the 2021 Census released on August 17, but it anticipates that, with the application of the modified Regulations, some 700 currently unilingual federal offices will become bilingual over the next few years.

Finally, the President pointed out that Bill C-13 is a crucial step forward in revitalizing the governance of Canada's official languages for the future. Ms. Fortier concluded: "Our official languages are our strength. They contribute to our diversity and inclusiveness, our social cohesion and resilience."

During concurrent sessions, participants discussed demographic trends and substantive equality, economic development, integration and retention of newcomers, access to services, continuum in education, access to second-language learning, linguistic and cultural exchanges, equity-seeking groups amongst official language minority communities, and international perspectives on the promotion of both official languages, amongst other things.

Like other federal institutions, the Treasury Board Secretariat's Official Languages Centre of Excellence held an information booth in the hallways of the NAC to respond to questions from participants and boost the advances that the Regulations will bring in terms of service delivery for official language minority communities.
