

### 2024 Western Region Wildfire Summary


PSPC Western Region experienced a notable wildfire season in 2024. Despite a 52% reduction in the total area burned and only a slight increase in the number of fires compared to 2023, the severity of the impacts remained significant. The Jasper Wildfire, in particular, has been classified as <u>Canada's second costliest fire event</u> and the sixth costliest natural disaster in the nation's history.

Extreme weather events continue to escalate across Canada, with flooding, hail, wildfires, tornadoes, and other severe occurrences posing substantial threats. Please read through the information in this email for mitigation tips, business continuity guides, and emergency procurement information.

\*Please note that PSPC Western Region encompasses Alberta, Saskatchewan, Manitoba, Northwest Territories, and Nunavut. However, wildfire data is only available for AB, SK, MB, and NT, as no data was reported for NU.




**PSPC Western Region Total Area Affected** 




**PSPC Western Region Total Number of Fires** 

# 2024 total hectares burned by wildfires in PSPC Western Region





## **Preparing for Wildfires**

The following tips from the National Service Call Centre are aimed at increasing resiliency in preparing for potential impacts by wildfires. These are pre-planning activities aimed at reducing risks to buildings and assets and to improve smoke management readiness. \*As a reminder in the event of an impact to assets and/or occupancy, the incident process must be initiated by contacting the National Service Call Centre (NSCC) at 1-800-463-1850.

#### **Outdoor Precautions:**

- Create and maintain fire break zones around buildings.
- Remove debris and combustible materials.
- Maintain vegetation and landscaping.
- Clear access routes for emergency vehicles.
- Install ember-resistant mesh on potential entry points.

#### **Review and Update Plans:**

- Update wildfire checklists and evacuation routes
- · Confirm emergency contact lists.
- · Conduct fire drills.

#### **Indoor Smoke Management:**

- Use MERV 13 filters or higher for HVAC systems.
- Consider additional filtration or portable air cleaners.
- Ensure HVAC systems are properly sealed and maintained.
- Prevent infiltration of outdoor air pollutants.

### **Emergency Procurement**

The Treasury Board's <u>Directive on the Management of Procurement</u> outlines procedures for emergency contracting in emergency situations. Departments are authorized to enter into contracts up to \$3 million CAD, including taxes and fees, under pressing emergencies if certain criteria are met. Additionally, PSPC can issue non-competitive contracts up to \$25 million CAD for any department.
